UNIVERSITY OF THE VIRGIN ISLANDS BUDGET RESOLUTION FISCAL YEAR 2006-2007

Authorizing the FY 2007 appropriation request for operating, debt service and other mandated programs.

WHEREAS, the University received communication dated January 12, 2006 from the Office of Management and Budget (OMB) of the Government wherein OMB issued the Fiscal Year 2007 Budget Call. OMB advised the University of its General Fund Expenditure Ceiling of \$30,098,070, based on projected revenues for Fiscal Year 2007 for the Government of the Virgin Islands; and

WHEREAS, the Virgin Islands Government appropriation to the University for FY 2006 was as follows:

WHEREAS, that level of appropriation enabled the University to fund the following:

- (a) The cost of employee salaries and benefits, books, equipment, contracted services, incidental expenses and other expenses related to the operations of the University; and
- (b) The cost to provide legislatively mandated programs for veterans, senior citizens, the National Guard, valedictorians, salutatorians, academic and cultural awards endowments and the SBDC local match.

WHEREAS, through the Omnibus Authorization Act of 2006, the Virgin Islands Government appropriated \$2,500,000 to the University for salary increases; and

WHEREAS, a modest provision of \$1,108,538 to offset costs for more pressing equipment replacement needs and incidents of plant deterioration which have remained unaddressed for the past several years.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- That the University is authorized to request the sum of \$27,288,640 in its Section 1. FY 2007 appropriation to cover operating costs.
- That for the purpose of financing the operations of the University, meeting Section 2. debt service requirements, plant and equipment renewals and replacements, funding Legislatively Mandated Programs, and providing for other purposes and requirements, the President and the Vice President for Administration and Finance are authorized to prepare, and present for Legislative consideration the following appropriation request:
