

PRESIDENT'S REPORT TO THE BOARD OF TRUSTEES OF THE UNIVERSITY OF THE VIRGIN ISLANDS

The President's Report for this reporting period is organized into two sections. Part I provides highlights of new and ongoing presidential initiatives and institutional accomplishments since the last report. Part II highlights major accomplishments within the framework of *Greatness Through Innovation*, the University's current strategic plan.

This framework has been adopted to ensure that all Components and Departments across the University are focused on areas that the University has determined are critical to our future success. I continue to be extremely impressed with the productivity and commitment of our University's students, faculty, staff and administrators.

PART I: PRESIDENTIAL INITIATIVES AND ACCOMPLISHMENTS

I am honored to share with the Board of Trustees highlights of the University's activities and achievements for the reporting period. This section contains some of the major achievements of the University. These accomplishments speak to the commitment and resilience of our students, faculty, staff and administrators.

UVI MOURNS THE LOSS OF FIRST CVI PRESIDENT, DR. LAWRENCE WANLASS



On December 18, 2018, the first president of the University of the Virgin Islands, Dr. Lawrence Wanlass, passed away in California. He is survived by his wife, Anita, and their four children. For nearly two decades – from 1962 to 1980 – Wanlass worked to establish the then College of the Virgin Islands and to create a world-class curriculum for its students. UVI President Dr. David Hall, on the behalf of the entire University family – the Board of Trustees, foundation boards, faculty, staff, students and alumni – extended his sincerest condolences to the family, friends and loved ones of Dr. Wanlass. Under Dr. Wanlass' leadership, the institution was designated with land-grant status and a large endowment was bestowed on the College through federal legislation. During his tenure, Hubert Sugden donated his St. Croix home, which would become UVI's Albert A. Sheen Campus on St. Croix and the institution received an endowment for the establishment of the Reichhold Center for the Arts.

Dr. Wanlass was instrumental in the establishment of CVI's initially offering two-year transfer programs in humanities, social sciences, physical science and mathematics, business administration, engineering and teacher education, as well as occupational programs in business management, accounting, executive secretarial studies, hotel and resort operation and management, electrical technology and construction technology. Later, he was instrumental in the establishment of four-year academic programs and in the accreditation of the College for five years by the Middle States Association. In 1980, upon Dr. Wanlass' retirement, in honor of his accomplishments, leadership and impact that he had on the development of the College of the Virgin Islands, was conferred the status of President Emeritus.

SIGNIFICANT INSTITUTIONAL ACHIEVEMENTS

UVI BECOMES FIRST HBCU TO OFFER FREE TUITION AND THE SECOND JURISDICTION TO OFFER FOUR-YEAR FREE TUITION

On January 4, 2019, Governor Kenneth E. Mapp signed into law Act 8155, entitled the Virgin Islands Higher Education Scholarship Program, as one of his last acts as Governor. This Act is part of a national movement that is attempting to transform the nation's understanding of the role and importance of higher education to the future of this country. This Bill was introduced by Senator Tregenza Roach, who now serves as Lieutenant Governor, and was unanimously supported by the 32nd Legislature.

Through the recent support of our local government, students can now receive free tuition at the University of the Virgin Islands. Presently, the Virgin Islands lags behind all states in regards to the percentage of individuals with college degrees (11.4%). This reality stifles the economic development of the Territory and deprives businesses of the trained workforce that is necessary for them to remain and prosper. The adoption of this policy also places the Territory and UVI as national leaders in higher education. The U.S. Virgin Islands now stands as the first Territory in the U.S. to fund this innovative approach, following the lead of only one other state that provides tuition free bachelor degrees. UVI is also the first Historically Black College and University (HBCU) in the nation to offer free tuition to residents of its home state/territory.

In a special session on January 23, 2019, the UVI Board of Trustees approved policies and procedures to aide with the implementation of the free tuition legislation. The Free Tuition Scholarship will be available to all Virgin Islanders, as defined in the legislation, who enroll as full-time students pursuing their first associate's degree or bachelor's degree regardless of age, date of graduation or household income. Recipients of the free tuition aid, which would supplement students' federal scholarship awards, University scholarships, and private donations, will be required to maintain a cumulative grade point average (GPA) of 2.5 and to work in the Territory for a specific length of time upon completion of their studies. The University will collaborate with the Department of Labor to secure job placement opportunities for scholarship recipients. The deadline for students to apply for the Fall 2019 semester is March 1.

This landmark legislation has received considerable local, national and social media attention. An editorial by President Hall entitled "A Compelling Case for Free Tuition" was published in the Avis, Source, Daily News and other local media online newspapers. A national editorial is also currently being finalized.

FREE TUITION RETENTION AND ACADEMIC SUPPORT FRAMEWORK

What truly makes the Virgin Islands approach to free tuition unique and compelling is that funds are also being set aside to support students in their quest to excel. The Free Tuition Act provides funding so that the University can establish new academic support programs to help more students in high school obtain a 2.5 GPA and new programs at the college level that will allow them to maintain a 2.5 GPA. Since financial assistance alone is not enough for some students, this Act creates a comprehensive remedy to what ails higher education. This aspect of the Act strategically empowers the University to make free tuition eventually available to every student in the Virgin Islands, regardless of their present performance. If they are willing to work hard and embrace the insights, support and guidance which will be provided, they can take advantage of this opportunity. The regulations passed by the Board of Trustees permit high school students who have not obtained a 2.5 GPA in high school, to still receive funding if they obtain it while at UVI.

The University has developed a comprehensive retention and academic support strategy aimed at improving student success and persistence. The framework includes both a pre-college and in-college approach to assist students and will consist of the following:

Pre-College

- 1. UVI will develop a 10th Grade Academic Boost Summer program, based on its current UVI Boost Program. The local high schools will identify 10th grade students whose GPA is below 2.5 (converted from the high school average) but who have an interest and desire to attend college. These students will participate in an intensive 5-week program on campus that empowers them to develop skills which will increase their chances in excelling in the courses that they will take for the next two years. Additionally, the program will focus on non-cognitive skills to strengthen self-efficacy. The program will include tutors and near peer coaches (college students) available to work with students throughout the academic year. The program and all materials will be free to the students, and if they achieve the goal, they will be eligible for the Free Tuition Scholarship.
- 2. Working with the Commissioner of Education, UVI will identify ways in which students will be tested/identified at various intervals while in middle, junior high and high school. If they are deemed to have a deficient background, special support will be provided. UVI Mathematics and English/Language Arts professors will work with school (K-12) mathematics and language arts teachers to identify curricular enhancement materials that will serve as a resource for the middle, junior high and high schools.
- 3. Expand and appropriately fund the Dual Enrollment program by connecting the Dual Enrollment program to our 3-year accelerated option. This will require hiring adjunct faculty to offer more college credit courses in the secondary schools.

In College Program

- 1. Expand the UVI Boost program to include all students whose GPA are below 2.5, and especially target those who are not Pell Grant eligible.
- 2. Expand the Peer Academic Coaches program and assign each student participating in the UVI Boost Program a Peer Academic Coach. Students will need to meet with their Peer Academic Coach once per week.
 - Students will receive financial support from private sources that will be dependent on their attendance and completion of all support activities. Peer Academic Coaches and the Center for Student Success will have to certify that the students have in good faith fulfilled their responsibilities. This will be recorded in BucsConnect.

UVI TO LEAD THE DEVELOPMENT OF MULTI-HAZARD MITIGATION PLAN FOR THE U.S. VIRGIN ISLANDS

As part of a joint effort between the Virgin Islands Territorial Emergency Management Agency (VITEMA) and the University of the Virgin Islands serving as project lead, the Federal Emergency Management Agency (FEMA) awarded \$4,932,697 for the development of a Territorial Multi-Hazard Mitigation Plan (HMRP) for the U.S. Virgin Islands. Our Virgin Islands Experimental Program to Stimulate Competitive Research (VI-EPSCoR) and the Caribbean Green Technology Center will work in conjunction with VITEMA on the development of the hazard mitigation plan over the course of the three-year project. We view this effort as an opportunity to enhance the position of the University as a key resource of intellectual and technical capacity for the Territory and the region, as part of our collective recovery and rebuilding efforts. This goal aligns with the University's strategic plan to develop a Disaster Mitigation and Resiliency Center.

NOAA ENVIRONMENTAL LITERACY PROGRAM AWARDS UVI \$500,000 IN FUNDS TO ADVANCE USVI COMMUNITY RESILIENCE TO HURRICANES

UVI was awarded \$500,000 in funding from the National Oceanic and Atmospheric Administration (NOAA) Environmental Literacy Program (ELP) for its U.S. Virgin Islands (USVI) Storm Strong Program. The five-year project will create the Territory's first sustained, community-based, hurricane hazard preparedness program. Through new and strengthened partnerships and the development of a long-term community-based program, middle- and high school youth and their families across the Territory, will engage in on-the-ground projects that increase individual, family, and community preparedness for hurricanes. This project joins previously ELP-funded resilience education projects that support the education of K-12 students and the public so they are knowledgeable of the ways in which their community can become more resilient to extreme weather events and or other environmental hazards, and become actively involved in achieving that resilience.

UVI SELECTED TO CONDUCT 2020 V.I. CENSUS

The University was selected by the U.S. Census Bureau to conduct the data collection requirements of the 2020 census for the U.S. Virgin Islands. UVI will execute and manage all activities associated with the collection and reporting of the decennial census data to include demographic, social, economic and housing characteristics of the Territory. The total estimated contract award amount is \$15,454,102. As part of the scope of the contract, UVI will establish U.S. Census Virgin Islands offices on both St. Thomas and St. Croix. The University project lead for the 2020 VI Census is Dr. Frank Mills, Vice Provost for Research & Public Service.

WEST RESIDENCE HALL OPERATIONAL ON ST. THOMAS CAMPUS

The University is continuing with its campus restoration projects post hurricanes Irma and Maria. Repairs to West Residence Hall was a priority to accommodate the number of students seeking residence on campus and in preparation for the Spring 2019 semester. The immediate task was remediation of mold in the facility which were successfully completed by an external vendor. Roof repairs, mitigation and wall replacement were also completed. Furniture was ordered and installed. The West Hall project is complete except for minor finishing touches. The West Residence Hall is now back on line with students occupying the facility. This is a major achievement for the institution in its rebuilding process and significantly reduces the number of students who were on a wait-list for on-campus housing.

UVI PHD RESIDENCY IN INDIA

The Creativity in Leadership, Innovation and Change (CLIC) Ph.D. program held its inaugural global residency in India from December 12-22, 2018. A total of 17 persons participated in the program including ten students in Cohort 2, two students from Cohort 1 and one student from Cohort 3. The students were engaged in lectures and workshops conducted by Indian officials and scholars on topics including women empowerment, leadership and creativity. The focus of the residency was on ethics and social justice and included visits to Mother Teresa's house and to a home for young women rescued from the sex trade in Kolkata, India. Other international residencies are planned for the future.

UVI HUMAN RESOURCES PROFESSIONALS SERVE AS CERTIFIED TSA TRUSTED AGENTS

Three Human Resources professionals are Certified Trusted Agents with the Transportation Security Administration (TSA) authorized by IDEMIA to enroll individuals for security identification programs offered by IDEMIA. IDEMIA is a third party administrator hired by the TSA to conduct pre-check screening certification for land, sea and air, requested the UVI Human Resources (HR) Department to serve as an enrollment center for the U.S. Virgin Islands and to allow representatives from our HR Department to serve as Trusted Agents to enroll individuals requesting TSA pre-check authorization and Transportation Worker Identification Certification (TWIC). The HR Office enrollment center began processing enrollees on November 5, 2018 and has completed approximately 400 applications thus far.

UVI MUSIC DEPARTMENT HOSTS SUCCESSFUL COMMUNITY CONCERTS

On St. Croix, UVI's Voices of Inspiration Community Choir hosted its first fundraising Gala on Sunday, December 2, 2018 under the theme, *Pay it Forward: Meet the Voices*. Voices of Inspiration once again transformed the Great Hall on the Albert A. Sheen Campus and impressed the audience with Christmas songs, and original pieces composed by Director Josephine Thomas-Lewis. The overarching goal of this initiative was to provide an intimate setting to introduce the 35 members to the community and celebrate its successes and share the next phase of the organization. Additionally, Voices of Inspiration recognized and thanked Dr. Simon Jones-Hendrickson who was very instrumental in the choir gaining exposure by travelling and performing in St. Kitts in 2016. President Hall was also among those recognized for his vision and support in reinvigorating a choir on the St. Croix campus. The next phase of Voices of Inspiration will include the production of an original CD and travel to London, UK in summer 2019. The fundraising event received overwhelming support from the community and local businesses and raised over \$11,000 to support upcoming initiatives. Several supporters included TEAM Consultants, Sunny Isle Baptist Church, Acute Alternative Medical Group and the University's Office of the President.

On St. Thomas, a *Pre-Holiday Concert* was held on November 9, 2018 at the Prior Jollek Hall featuring UVI's Concert Band, Concert Choir, Jazz Ensemble and Steel Pan Ensemble to a well-received audience. The concert opened with selections from our newly formed Chamber Ensembles (these Ensembles will officially be part of our new Music Bachelor's in Fine Arts (BFA) degree program which comes on line in Fall 2019). The other concert performances included the Saxophone Ensemble, led by UVI Music major Mr. Sherwin Williams ('20) and the Trombone Ensemble, directed by Dr. Leroy V. Trotman; the Concert Band directed by Ms. Georgia Francis; the Concert Choir directed by Ms. Jeannette Rhymer; the Steel Pan Ensemble directed by Ms. Shenelle Warner; the Jazz Ensemble directed by Mr. Dion Parson, UVI Music Department Chair. All the performances showcased our talented students performing many of the holiday classics as well as an original Christmas song, written specifically for this concert.

GREATNESS THROUGH INNOVATION STRATEGIC PLAN

The UVI Board of Trustees approved the University's new strategic plan, "Greatness Through Innovation," at its October 2018 Board meeting. The adoption of the new strategic plan is the first major step towards creating a culture of innovation. Throughout Greatness Through Innovation, the goals and measurable objectives all point towards the creation of an university where its emphasis, incentives, and processes stimulate and nurture innovative ideas. Excellent teaching, research, and community engagement are still the fundamental pillars upon which the institution stands, though we plan to fulfill this mission through creative and innovative strategies and initiatives. The University is planning an official public launch of the new strategic plan in March 2019. The Greatness Through Innovation promotional materials have been finalized and will be available at these planned events.



MSNBC CORRESPONDENT JOY-ANN REID SELECTED AS UVI COMMENCEMENT 2019 KEYNOTE SPEAKER

Ms. Joy-Ann Reid has agreed to serve as UVI's 2019 commencement keynote speaker on May16-17, 2019 on St. Croix and St. Thomas, respectively. Ms. Reid is a host, author and political analyst at MSNBC and host of "AM Joy," which airs Saturdays and Sundays from 10 A.M. ET to noon ET. She is the author of the book Fracture: Barack Obama, the Clintons and the Racial Divide (William Morrow/Harper Collins 2015) and the co-editor, with Washington Post columnist E.J. Dionne, of We Are the Change We Seek: The Speeches of Barack Obama (Bloomsbury, 2016). Her columns and articles have appeared in The New York Times, The Guardian, the Miami Herald, New York Magazine, The Daily Beast and other publications. This year's local honorees will be Cornel Williams on the St. Thomas Campus and Dr. Simon Jones-Hendrickson on the Albert A. Sheen Campus. Mr. Williams is a well-respected business leader, community philanthropist, visionary and dedicated UVI alumni. Dr. Jones-Hendrickson, who last served as Dean of the College of Liberal Arts & Social Sciences before his retirement, is an accomplished scholar, economic guru, Caribbean cultural keeper and superb professor.

PRESIDENT'S APPRECIATION AWARD

During this past fiscal year, we witnessed a significant increase in the number of external awards received by the University from various federal agencies for research projects and other programs. For fiscal year 2018, UVI received \$19.3 Million in externally funded grants and contract awards as compared to the prior fiscal year of \$7.7 Million. This substantial increase is due to the hard work, creativity and dedication of numerous Principal Investigators at UVI. Our faculty researchers have made a significant contribution to this increase as well as other administrators and teaching faculty. UVI continues to be ranked among the top institutions in regards to external research dollars in comparison to its peer and aspirational peers and this result has been consistent over the years. This significant achievement has occurred despite the fact that the University's research infrastructure needs to be enhanced.

PART II: GREATNESS THROUGH INNOVATION INITIATIVES AND ACTIVITIES

AREA OF FOCUS #1: INNOVATION & DISTINCTION

- Through funding from Title III, the on-campus child-care center on St. Thomas is near completion. Contractors renovated 3,168 square feet of each of the two designated buildings and added approximately 2,300 square feet of back yard fencing.
- The Medical School Simulation Center on St. Croix has resumed construction. A revised construction schedule for Phase 2 was submitted with a completion date of March 6, 2019 due to delays caused by rain and problems experienced with shipping containers of materials, roof and windows to St. Croix. All required materials for Phase 2 are now on-site. Completion of the final phase (Phase 3) is anticipated to occur in late summer.

AREA OF FOCUS #2: LEADERSHIP & EXCELLENCE IN ACADEMICS, RESEARCH, & PUBLIC SERVICE

- The College of Science and Mathematics held its 19th Annual Student Research Symposium on Saturday, September 22, 2018, in the UVI Administration and Conference Center. The Symposium included 43 presentations by over 60 UVI students.
- The Office of Research and Public Service, together with the Eastern Caribbean Center (ECC), conducted and reported on a Local Food Consumer Survey and a Local Farmers Survey, which contributed to the USVI Agricultural Processing/Packaging Plant Feasibility Study report (prepared by UVI's Institute for Leadership and Organizational Effectiveness). In August 2018, ECC completed the report of the Parent Satisfaction with Special Education Services Survey 2016 to the VI State Office of Special Education and made public presentations of the special education survey results on both St. Thomas and St. Croix in September 2018.

• Virgin Islands Experimental Program to Stimulate Competitive Research (VI- EPSCoR) St. Croix staff executed a Memorandum of Understanding with the Claude O. Markoe Elementary School for their "Elementary STEM" Pilot Project. Through this agreement, VI-EPSCoR provided 25 Lego WeDo 2.0 kits, pilot project support through access to STEM project implementation personnel, instruction in Creative Problem Solving, and the assistance of project evaluation specialists for preand post-test assessments. The school will utilize the equipment provided by VI-EPSCoR to introduce students to the basic principles of coding and robotics. The estimated value of the financial support is \$5,000.

AREA OF FOCUS #3: STUDENT SUCCESS AND ACHIEVEMENT

- Two students are participating in the Danish Student Exchange/Scholarship Program in Denmark at the University of Copenhagen for the Spring semester. The program is part of UVI's global student exchange programs which has resulted in UVI hosting students from those institutions over the past few years. Funding for UVI student participation comes from the Danish Government Scholarship, which provides for their housing and living expenses while in Denmark.
- Eight St. Croix students from MAT 557, Action Research in Mathematics, traveled together with faculty member Dr. Chris Plyley to present their educational research projects at the 7th Annual International STEM Educators Association STEM Exposition and Conference from October 7-9, 2018, in Branson, Missouri.
- The campus student newspaper, UVI Voice 2.0, has been reactivated. The Office of Public Relations is working closely with Dr. Sharon Honore to create a quality product, which is produced by students. Plans are underway to structure the paper as a self-sustaining business endeavor, complete with a paid editorial staff, marketing component and in-house advertising division. UVI Voice 2.0 will align with other student newspapers and become Caribbean centered, organized and maintained by a student team of journalists. UVI Voice 2.0 was launched December 8, 2018, with plans for ongoing publications. The general UVI student body is encouraged to submit articles for review and selection. Final selections are then edited and formatted using internet software. The current e-publication may be found at (https://uvivoice2018.wixsite.com/website).

AREA OF FOCUS # 4: MEASUREMENT, ANALYSIS, KNOWLEDGE MANAGEMENT, & RESULTS

The University's Enterprise Resource Planning (ERP) application, Banner, was moved outside of the campus environment and Territory to Microsoft's Azure Cloud. This move ensures uptime and the resilience of this key tool used for human resources, payroll, budgeting, registration, purchasing, financial aid and other University functions. On-the-ground interruptions to electricity, network, air conditioning or other conditions will not impact Banner. As long as one has access to the Internet, Banner will be accessible and University operations can continue. This ensures business continuity no matter the on-the-ground reality with the physical campuses.

AREA OF FOCUS #5: OPERATIONAL EFFICIENCIES AND FOCUS

- Between October 1 and December 31, 2018, more than \$1M has been secured from foundations and corporations since the beginning of the fiscal year. This represents support from twenty organizations. Areas for which funding was procured include support for scholarships, faculty and student research, the Reichhold Center for the Arts, Afternoon on the Green, programs in the College of Science and Mathematics and School of Business, School of Nursing, UVI CELL, and scholarships.
- As directed by the Vice President for Administration and Finance, the Human Resources Department implemented the FY2019 Salary Compensation Plan on November 28, 2018 to be processed with the last three payrolls for 2018, (bi-weekly 26, and monthly for administrators and faculty). During this reporting period, the staff was tasked with testing ITS upgrades from BANNER 8 to BANNER 9 and also to BANNER Cloud in a test environment, in addition to entering data in our normal work environment. Although testing proved to be very time consuming and interrupted the normal flow of work in the department, the staff successfully worked in the test environment to finalize timely compensation increases for all applicable employees.
- The Grants and Contracts area is starting to draw cash from the federal agencies' electronic systems again after the federal government shut down ended. Electronic payment systems were down from December 22, 2018, but funds are now accessible for draw. Accountants are submitting FY 2018 waived SF425 reports from FY 2017. Accountants are also involved in the FY 2018 Financial and A-133 Single Audits.

A grant accountant position was filled. The individual started in the Grants and Contracts area November 2018 and is currently being trained on US Department of Education Title III and Title IV programs. In addition, a Post Award Grants Coordinator was hired to assist grant accountants with an overall review of the Accounting Office Service Charter and holding workshops and meetings with principal investigators and administrators. As a result, the Grants and Contract area has been reassigning existing grants and assigning new grant awards.

- The financial and single audit for the year ended September 30, 2018 initially commenced on November 12th, 2018. The audit of fiscal year 2017 was completed and issued on October 12, 2018. The late issuance of the report did not leave sufficient time for the Accounting staff to implement the necessary changes prior to the end of fiscal year 2018. As a result, management determined, and the auditors agreed that the audit should be paused until January 2019. Accounting provided an updated trial balance to the auditors on January 11, 2019 and audit fieldwork resumed on January 14th, 2019. The audit is currently on schedule to be issued by the established deadline of March 31, 2019. The Accounting team, with the assistance of the Office of Administration and Finance is working diligently to ensure the audit is issued on time.
- Institutional Effectiveness staff is meeting with unit heads on the recommendations from 2017 and 2018 UVINext recommendations. One-on-one meetings are also being held with persons with responsibility for Greatness Through Innovation objectives. Institutional Effectiveness staff will ultimately establish regular communications with University stakeholders ensuring Unit missions are tied to that of the University, goals and objectives are in line with the new strategic plan, and that assessment activities measure and track progress.
- Despite the many challenges the St. Thomas Security department encountered during this quarter, the department received positive recognition from various internal and external constituent groups. The Security Department, though numerically small, demonstrated the strength of the unit by successfully providing security services for the UVI Community and visiting groups to the campus throughout the ongoing restoration following hurricanes Irma and Maria. Additionally, the unit continues to meet Peace Officers Standards and Training (POST) requirements in the following areas: appropriate usage of firearms and non-lethal weapons, handcuffing, CPR and First Aid, search and seizure, self-defense, report writing, ASP baton, pepper/OC spray, and usage and instructions regarding other relevant equipment and general duties of security officers.
- Demolition activity of the UVI Research and Technology Park (UVIRTP) as per specifications outlined began on January 7, 2019, with a projected completion date of March 31, 2019. Additionally, materials not noted in the specifications such as the soffit on both floors, multiple layers of drywalls and corroded metal studs were under review. Presently the scope of work is 35% completed and anticipated completion is scheduled for March 31, 2019.
- The 120-ton chillers for the Administration & Conference Center building incurred irreparable damage as a result of the hurricanes. The units were successfully replaced and the project was completed in January 2019.
- The interior carpet throughout the Administration & Conference building was substantially damaged. In some cases, removal of the carpet was necessary for the maintenance of satisfactory Indoor Air Quality (IAQ). The carpet was successfully replaced in the conference rooms and two hallways. The second floor hallway installation is pending final material procurement.

- The Campus Accessible Lifts on the upper St. Thomas Campus sustained considerable damage due to their location outside of the buildings and exposure to the elements. The project is awaiting shipment of the lifts.
- The renovation of the Reichhold Center for the Arts is still a work in progress. The main roof that covered the core facility was compromised due to major structural damage as a result of the hurricanes. Do Right Construction was instrumental in removal of the compromised roof structure and remaining roofing sections in the facility. The project was completed in December 2018. Mold remediation work is currently in progress. The As-Built drawing is completed. Building code compliant design and ADA review and design are still in progress. Schematic design to be completed February 2019.
- School of Business Building: The As-Built drawing according to measurements and steps is completed. Delivery of auditorium seats, building code compliant design, ADA review and design are still to be completed scheduled completion of schematic design is expected February 2019.
- Quarters B Incomplete: The As-Built drawing is completed. The building code compliant design and ADA review and design are in progress-- schematic design scheduled completion February 2019.
- School of Nursing: The As-Built drawing is 90% completed.
- Marine Science Building: UVI received verbal approval to proceed. Building code compliant design and ADA review and design are in progress. Schematic design scheduled completion February 2019.
- Bus Shelter Replacement: The bus shelter located adjacent to the Music Building was destroyed during the hurricanes. The shelter was replaced July 2018.
- Campus Fleet Upgrade: The STT Campus Vehicle Fleet was plagued with vehicles past their mechanical age for durability and safe operations and a number of them were retired from operation. A fleet upgrade proved necessary – vehicles were replaced and/or purchased. Fleet upgrade completed.
- Two 25-ton HVAC units with high Energy Efficient Rating (EER) HVAC Equipment, and EPA compliant R-410a were replaced and installed and the associated ductwork repairs completed at the Research Extension Center. The units will serve the one-story, approximately 10,000 sq. ft. REC Building which was built in 1993. The units were approved for the Albert A. Sheen Campus to assist with "Creating the Foundation of a Sustainable Campus" through its advanced energy monitoring system and equipment upgrades.

- Securing and Protection of the College of Science and Mathematics (CSM) Casework and Equipment: The scope of work covered the protection of casework and equipment at the College of Science and Mathematics (CSM) following facility damage experienced at the RTPark from Hurricane Maria in September 2017. The project required removal of all wall mounted cabinets and the casement and equipment stored and protected from construction debris while demolition and reconstruction activities were on-going. Celestine was awarded the contract as a qualified contractor capable of performing the services required. The project was completed January 24, 2019.
- The Office of Compliance and Campus Operations on the Albert A. Sheen Campus, collaborated with UVI Physical Plant, in conducting an internal inspection of the Research and Extension Center on January 9, 2019, to evaluate the indoor air quality (IAQ) in areas of concern raised by an employee. ADCON Environmental, Inc. was contacted for a professional inspection of the entire ductwork system which resulted in them being hired on January 11, 2019, to provide cleaning and sanitization of the entire ductwork system. ADCON was contracted as a sole source vendor due to the technical expertise needed. Work was conducted from January 18 through January 25, 2019. During the maintenance cleaning, the facility was closed for operations and all employees were temporarily relocated to other offices on campus. The facility was re-opened on January 28, 2019.
- In addition to Human Resources Week, informational sessions were offered annually. During the months of October and November, Supervisor and Administrative Support Training was also conducted, facilitated by one of HR's Business Partner. Some of the topics discussed were Conflict Resolution, Setting Priorities, How to handle Difficult People, use of the HR Policy Manual, the Benefits of Empowering Employees, and Communication Skills. Eighteen supervisors and staff members attended the Supervisor training and fifteen staff members attended the administrative support training.
- One of the services offered with PeopleAdmin, the HR automated applicant tracking and performance evaluation system, is an automated on-boarding process. One of the HR Business Partners is working with a representative from PeopleAdmin to complete the set-up of this module in the PeopleAdmin system.

AREA OF FOCUS #6: VALUING OF PEOPLE, RELATIONSHIPS, & CULTURE

• On December 10, 2018, the Office of Student Activities, in collaboration with the Golden Key Honor Society, visited with participants of the Caribbean Center for Boys and Girls. Activities included painting and creating Christmas cards for their loved ones.

- Cooperative Extension Service (CES) staff organized and participated in the 34th Annual St. Thomas-St. John Agriculture and Food Fair held on November 17-18, 2018. The event was held at Bordeaux Farmers' Market in collaboration with the V.I. Department of Agriculture and We Grow Food Inc. The theme was "Building Bridges, Strengthening Bonds for a Better Farming Community."
- Culture Pop-Ups: The Reichhold Center partnered with the Department of Education Cultural Education Division to launch a series of hands-on workshops which focused on passing on cultural traditions of the Virgin Islands throughout the course of the academic year. Three workshops, Costume Building and Wire Bending (October); Traditional Games (November); and French Quadrille (December), were successfully conducted during the first quarter, two on St. Croix and one on St. Thomas. The Cultural Pop-Up events were jointly produced with the Department of Education and the Virgin Islands Council on the Arts.
- Domestic Violence, Sexual Assault Awareness: A one-woman show, entitled "Momma was a Bad Mutha...Shut Yo Mouth," was performed on October 2, 2018, by nationally acclaimed playwright Fee King. It relayed a powerful and victorious story about a woman surviving a childhood of sexual abuse, while witnessing domestic violence at her mother's house party. The event was a collaboration between Counseling Services, the Domestic Violence and Sexual Assault Council, Reichhold Center, and the College of Liberal Arts and Social Sciences. It was held at the UVI Little Theatre. Khalarni Rivers and Nyaila Callwood, wrote and performed their monologue entitled "It's a Code World" at the event. A total of 78 persons attended.
- The Reichhold Center staff assisted the Virgin Islands Council on the Arts (VICA) in revitalizing the 150-seat Dorsch Cultural Center amphitheater in Frederiksted, St. Croix. The Reichhold Center staff worked along with VICA in creating a small art gallery, office renovation, electrical upgrades and installation of lighting fixtures to enhance the audience and performance spaces. "The Dorsch" opened its doors on December 1, 2018 launching the festival season with Stanley and the Ten Sleepless Knights. Reichhold Center provided technical support for the grand opening.
- The Intra-Campus Basketball games were held during the weekend of October 19-21, 2018, on the St. Thomas Campus as an attempt to create an outreach activity that could unite both campuses and encourage intercollegiate sportsmanship.
- Sweet potatoes from the Biotechnology & Agroforestry program and lamb from the Animal Science program were donated to the Herbert Grigg Elderly Home, Queen Louis Home, My Brother's Table, The Village and The Lighthouse charities on St. Croix.
- The Hunting Ground, a documentary film about sexual assaults on US college and university campuses, institutional cover-ups, and the brutal social toll on victims and their families, was shown on campus as part of the Domestic Violence and Sexual Assault program activities. There were 75 students that participated in a discussion after the showing.

- Two interactive training activities, under the theme "Good Coconut Karma," were conducted throughout the Territory to educate farmers about food safety issues in general and the requirements of the USDA Food Safety Modernization Act Produce Safety Rule. Cooperative Extension Service (CES) sponsored and participated in the 3rd Annual Crucian Coconut Festival, which was organized by St. Croix Farmers in Action and held on the grounds of the historic Estate Bethlehem Sugar Factory.
- Virgin Islands Experimental Program to Stimulate Competitive Research (VI- EPSCoR) St. Thomas staff participated and served as an intermediate level instructor for the Virgin Islands Marine Advisory Service (VIMAS) Swimming Program. The VIMAS Swimming Program is a new program. It takes place during six consecutive Saturdays and focuses on teaching local under-represented minorities (URMs) how to swim, both as an important survival skill and as a means of becoming familiar with local near-shore ecosystems.
- Virgin Islands University Center for Excellence in Developmental Disabilities (VIUCEDD) held its annual Voices that Count forums on both campuses during this reporting period. These forums brought together political candidates and persons with disabilities and their families and advocates. A total of 224 persons attended.
