UM Accomplishments

During the 2005-2006 academic year, VISION 2012, the University's Strategic Plan for the period 2006-2012, was completed and implemented. VISION 2012 outlines the goals, objectives, and priorities necessary for UVI to grow into its role as an exceptional U.S. institution of higher education in the Caribbean. VISION 2012 is comprised of bold initiatives that are designed to improve student success, promote institutional excellence, and enhance the social and economic interests of the Territory.

UVI's accomplishments during the period are measured against the four Strategic Areas of Focus, as outlined in VISION 2012:

EDUCATIONAL EXCELLENCE

To continue UVI's ascendance as a premier institution of higher learning in the Caribbean

The University held its fourth Annual Spring Research Symposium on the St. Croix Campus to display students' scientific research and served as an example of student-faculty collaborative scholarship.

The University conferred its highest degree – the Education Specialist degree in School Psychology.

The University awarded, for the first time, a Bachelor of Science degree, in collaboration with Columbia University.

The institutionally supported student newspaper, UVI VOICE, was launched.

The University hosted the 2006 Summer Institute for Future Global Leaders in the Caribbean on the St. Thomas Campus. The institute attracted more than 40 university juniors, seniors, and first-year graduates from the Caribbean, the U.S. mainland and Europe.

INSTITUTIONAL IMPROVEMENT

To enhance the performance of our internal operations

VISION 2012, the University's Strategic Plan for the period 2006-2012, was completed and implemented.

As an initial step towards the re-affirmation of its accreditation, the University submitted to the Middle States Commission on Higher Education (MSCHE) its Self Study Design and completed a first draft of its Self Study Report.

The University implemented a three-year capacity-building project entitled Project Leap Frog. The Project is geared towards enhancing human capital and technological infrastructure needs within the institution.

Major renovations were completed on UVI's two marine facilities – the MacLean Marine Science Center (MMSC) on the St. Thomas Campus and the Virgin Islands Environmental Resource Stations (VIERS) on St. John. Renovations at MMSC included upgrading of research and teaching

laboratories and diving facilities; at VIERS, renovations included the construction of three laboratories and the installation of a new roof on the existing facility.

FINANCIAL SUSTAINABILITY

To ensure that this vital academic asset remains vibrant

The University exceeded its Annual Giving target for 2005-2006, receiving just over \$2 million in gifts, which included approximately \$1.1 million in cash.

The Reichhold Center for the Arts increased its receipt of private funding by approximately 40 percent.

The University received approximately \$10.1 million in grant awards, representing more than 50 awards. This represents a 15 percent increase over FY 2004-2005.

COMMUNITY ENGAGEMENT

To partner with others throughout the Caribbean to make this a better place to live and work.

The 26th Legislature awarded the University \$500,000 to conduct a public education program to educate the U.S. Virgin Islands' community about the planned 5th Constitutional Convention. The University embarked on the public education project and established a website, www.itsourfuture.vi to

house critical information pertaining to the project. In collaboration with the Office of the Governor, UVI CELL developed and coordinated the first of an Annual Occupational Safety and Health Conference. There were over 100 participants, representing government officials, business owners, and experts from OSHA.

UVI CELL entered into a Memorandum of Understanding with Homeland Security to manage training initiatives and provide marketing support for the Office of Homeland Security.

The Center for Marine and Environmental Studies, in partnership with the Nature and Ocean Conservancies, produced a DVD film on spawning aggregations and fisheries of the U.S. Virgin Islands.

The Small Business Development Center (SBDC) sponsored more than 40 training opportunities; completed more than 150 business-counseling cases and assisted entrepreneurs to secure independent loans totaling more than \$275,000 in small business funding.

SBDC assisted The Virgin Islands Farmers Cooperative, a cooperative of minority farmers, to obtain a technical assistance grant for \$172,950 from the USDA Rural Development Agency to prepare a feasibility study and business plan for dairy, livestock, vegetable and fruit production on St. Croix.



UM History

The University of the Virgin Islands was chartered by the Fourth Legislature of the Virgin Islands on March 16, 1962, as the College of the Virgin Islands — a publicly funded, coeducational, liberal arts institution. The first Board of Trustees took office in August 1963.

The first campus opened on St. Thomas in July 1963, on 175 acres donated by the federal government. In 1964 the college founded a second campus on St. Croix, on 130 acres also donated by the federal government. As a result of the purchase, in 2000, of an additional 211 acres on its westernmost edge, the St. Thomas campus currently encompasses 386 acres.

In addition to the associate of arts degree, which was the only degree offered at the outset, UVI now offers numerous baccalaureate degree programs, and five master's degree programs. A post-master's degree in educational psychology, an associate in applied science degree in process technology, and workforce training certificate programs are also offered.

In 1972 the College of the Virgin Islands was awarded land-grant status by the U.S. Congress. This allowed for the establishment of an Agricultural Experiment Station and a Cooperative Extension Service. In 1983 the U.S. Congress passed legislation establishing the University's Eastern Caribbean Center. Since then, many other areas have been added. These include the Reichhold Center for the Arts, the William P. MacLean Marine Science Center and the UVI Sports & Fitness Center, among others.

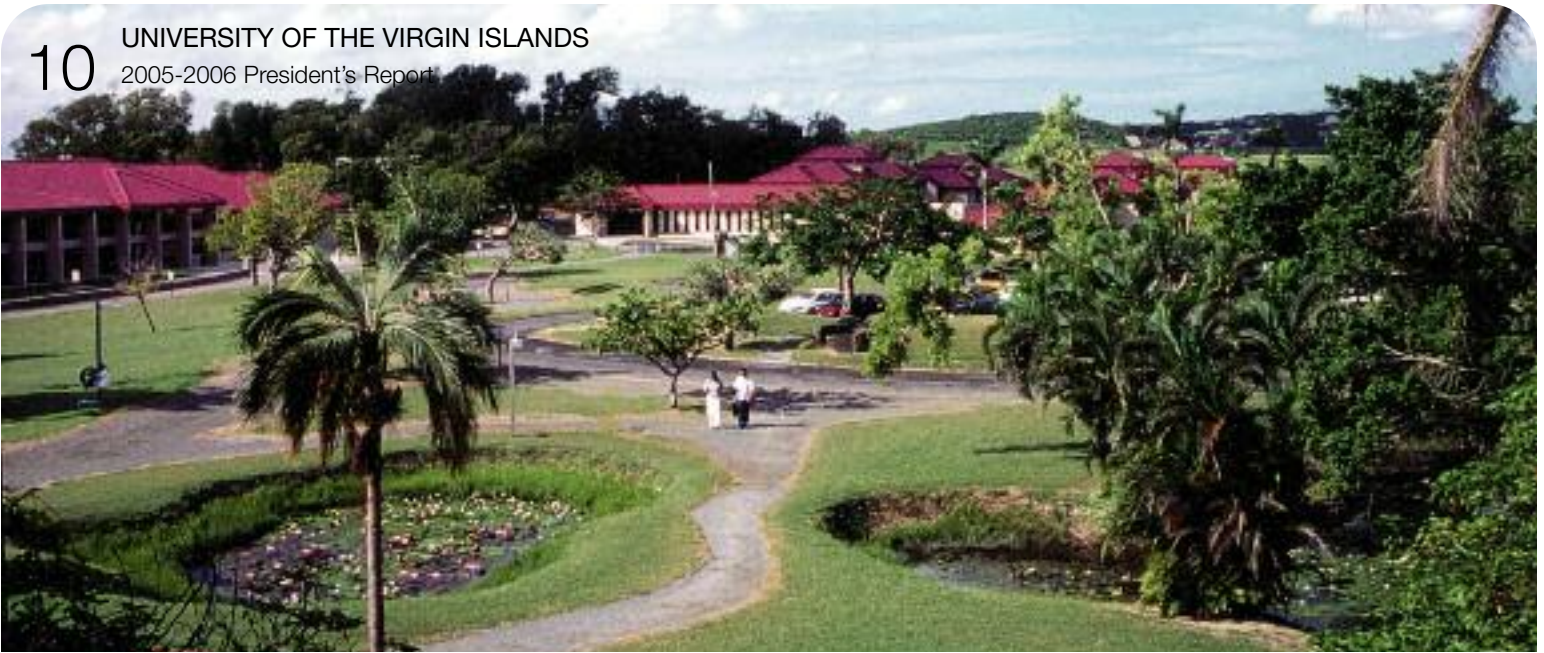
In 1986 the College of the Virgin Islands was renamed the University of the Virgin Islands to reflect the growth and diversification of its academic curricula, community and regional services, and research programs. That same year, the University

was designated one of America's Historically Black Colleges and Universities by the U.S. Congress. It is the only HBCU outside of the continental U.S., and it is the first to offer an undergraduate degree program in marine biology.

In 2002 Dr. LaVerne E. Ragster became the fourth and first female president of the University of the Virgin Islands, succeeding Dr. Orville Kean, who had served as president since 1990. Dr. Arthur A. Richards was president from 1980 to 1990. Lawrence C. Wanlass was the first president of the College of the Virgin Islands from 1962 to 1980.

Today, UVI enrolls approximately 2,500 full-time and part-time students on its two campuses. It continues to offer a high quality, affordable liberal arts education in a culturally diverse environment. The University boasts more than 5,000 alumni, many of whom have gone on to excel as doctors, lawyers, judges, university and government administrators, teachers, and other professionals. Among the many accomplished UVI alumni are two Rhodes scholars, the winner of a Pulitzer Prize for Journalism and the premier of Nevis.

UVI holds active membership in many higher education associations, including the Middle States Association of Colleges and Schools, and is accredited by the Commission on Higher Education of the Middle States Association. The University is also an active member of the American Association

of State Colleges and Universities, the American Association for Higher Education, the Association of Governing Boards, the National Association for Equal Opportunity, the National Association of State University and Land Grant Colleges, the American Council on Education, the Association of Caribbean Information Systems, and the Association of Caribbean Universities and Research Institutes.

Cooperative agreements between the University of the Virgin Islands and many other leading universities allow UVI students to receive degrees not offered on the UVI campuses. The Boston University School of Medicine cooperative agreement allows UVI students, after meeting certain qualifications, to be accepted provisionally into the medical school at the end of their sophomore year. These students spend two summers and their senior year at Boston University, graduate with a bachelor of science degree from the University of the Virgin Islands, and then proceed to complete medical school at Boston University. Additionally, there are less formalized transfer programs in pre-engineering, pre-pharmacy and pre-medical technology for students who wish to begin their studies in these fields at the University of the Virgin Islands before transferring to a specialized institution to complete their degrees.

Students in St. Martin and the British Virgin Islands earn bachelor's degrees via cohort programs the University of the Virgin Islands has established

with the University of St. Martin and H. Lavity Stoutt Community College in Tortola, respectively. UVI has also signed agreements with two other regional institutions, Dominica State College and Clarence F. Bryant College in St. Kitts, which will make it possible for graduates of these institutions to be admitted to upper-level courses in baccalaureate degree programs at UVI.

The National Student Exchange program operates on both the St. Thomas and St. Croix campuses. Each semester approximately 25 students from the U.S. mainland enroll through NSE. In addition, UVI continues to admit students via memoranda of understanding with the State University of New York at New Paltz, the College of Charleston, Emory University, Savannah State University (social work completion), Columbia University and Washington University in St. Louis (for engineering), UNINTER (Universidad Internacional de Cuernavaca, Mexico) and the Association of Caribbean Universities and Research Institutes (UNICA) Caribbean Exchange Program.

The University of the Virgin Islands is increasingly being recognized as a leading American institution of higher learning in the Caribbean. Under Dr. Ragster's leadership, the University will continue to fulfill its mission of providing superior academic instruction, conducting relevant research and engaging in public service activities that positively impact the territory, the region and beyond.

The Edith and Andre Galiber Endowment

Edith Rose Lewis Galiber likes to give. She gave the Virgin Islands community four decades of service as a public health nurse. She gives to charitable contributions across the nation. And she gives to the University of the Virgin Islands.

“My biggest contribution is that I make contributions,” Mrs. Galiber says about the impact her generosity has had over the years.

“I used to donate all over the country,” Mrs. Galiber remembers. “Once you do that you are on a list and then everybody starts sending you requests. I decided to put that money in the Virgin Islands,” she says. “I have my favorite charities,” Mrs. Galiber says of national causes that she continues to support. But much of her attention is directed towards causes in the territory. UVI is a benefactor of Mrs. Galiber’s decision to focus her philanthropic efforts in the territory.

In 2006 the University used \$100,000 of Mrs. Galiber’s and her late husband Dr. Andre Galiber’s gifts to create the Edith and Andre Galiber Endowment.

“I’m honored to have had this happen,” Mrs. Galiber says of the endowment. “We’ve always supported the University.”

“It’s really wonderful that the University is here,” she affirms. A graduate of the College of Saint Teresa in Winona, Minnesota, she remembers when there were no institutions of higher education

in the territory and high school graduates had to go to the U.S. mainland to earn degrees.

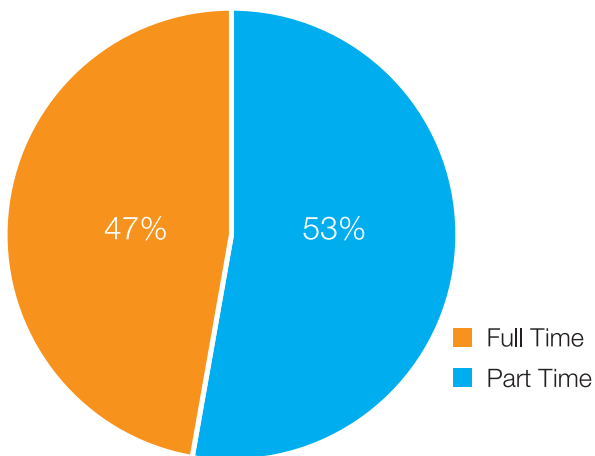
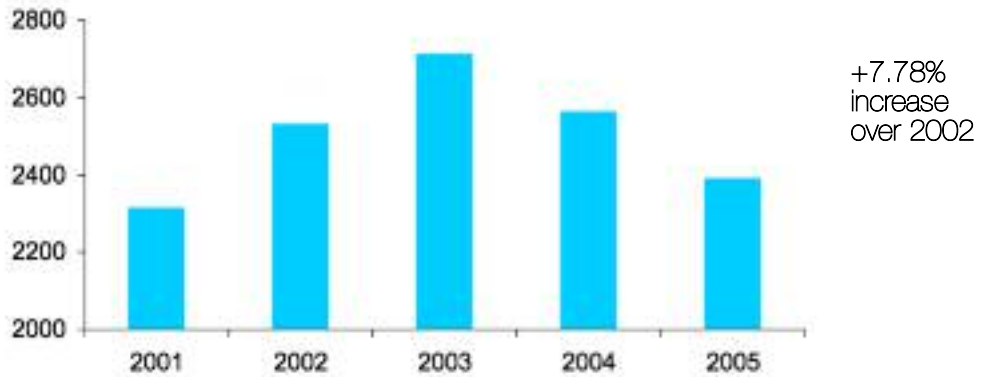
When the University was created 45 years ago as the College of the Virgin Islands, its mission garnered the support of the Galibers. “I wanted to support that because we needed it,” Mrs. Galiber recalls.

Mrs. Galiber retired from government service as the director of Public Health Nursing on St. Croix after a rewarding career. Born in St. Thomas she met Dr. Galiber at the Knud Hansen Memorial Hospital where she worked as a pediatric nurse and he was a medical student. His career and military service took them to Washington D.C. and Indianapolis. When the Galibers returned to the territory the family settled on St. Croix, where the services of Dr. Galiber, a radiologist, were needed.

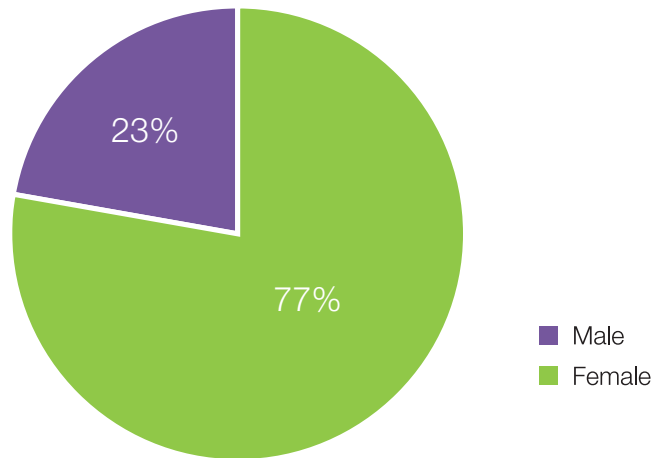
Although retired from public service, Mrs. Galiber works part-time and continues to give to the community through her involvement at Holy Cross Catholic Church and with the Delta Sigma Theta Sorority. She also remains a faithful supporter of health and educational causes in the territory. That’s just the spirit of Mrs. Galiber, the matriarch of a family that includes six children, 18 grandchildren and two pets. With an endowment at UVI her giving will continue forever. “I really support it,” says Mrs. Galiber about UVI. “I want it to be alive, to stay here and to grow.”

UVI Enrollment

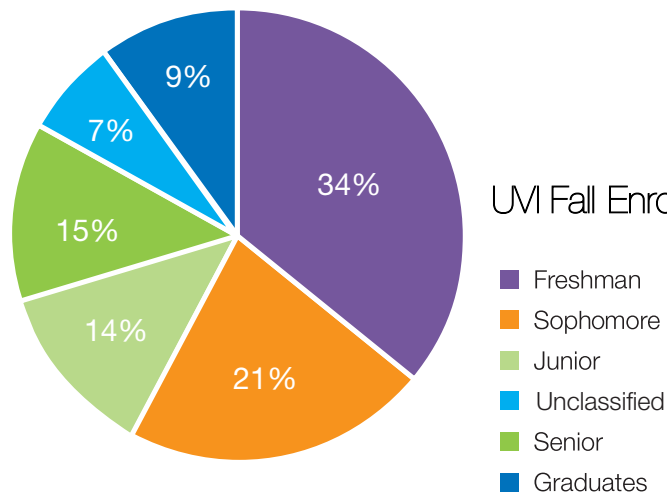
UVI Enrollment Fall 2001 - 2005

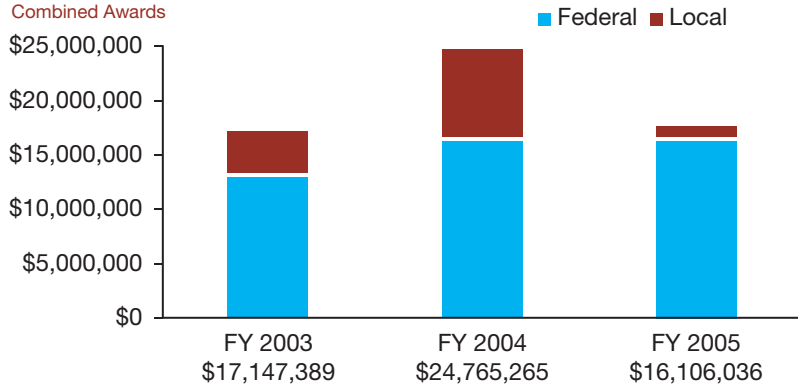

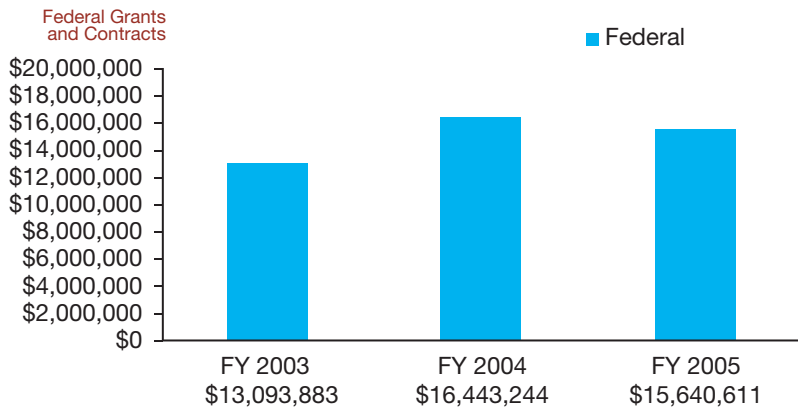

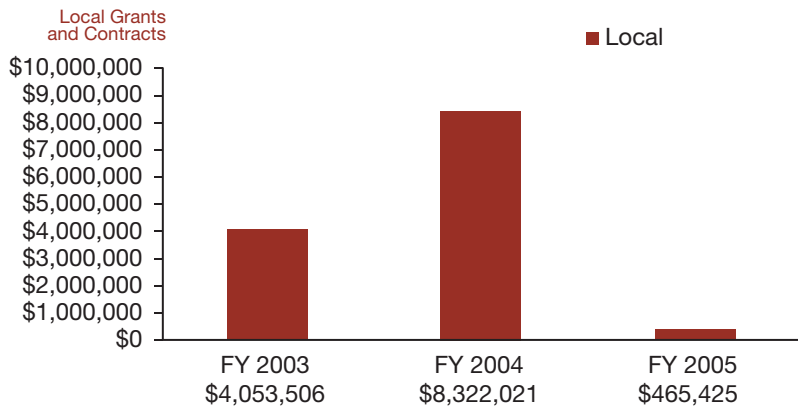
